Supporting documents must be translated in English, Finnish or Swedish and shall be presented in the following order. Applicant must show original documents at the VAC, but submit only photocopies of documents. The Consulate does not return any other documents to applicant than passports.

Schengen visa application form duly completed, dated and signed by the applicant (signatures in the field 37, field "multi-visa" in case of multientry and at the end of the application).			
Colour passport photograph; in line with ICAO standards , maximum 6 months old, background must be plain light-coloured, neutral face expression. The photo must not be edited.			
Valid passport/travel document and one photocopy of it (ID page and all pages containing markings). Must be valid for a minimum of 3 months after the planned journey and issued within the previous 10 years and have at least 2 blank pages.			
Travel medical insurance , covering the entire duration of the trip to Schengen area. The minimum coverage of 30 000 euros, non-deductible, covering: emergency medical expenses, hospital treatment, repatriation for medical reasons or death. It must be valid in the whole Schengen area or worldwide.			
<p>Journeys undertaken for sport or cultural reasons: Invitation, entry tickets, enrolments or programmes stating (wherever possible) the name of the host organisation and the length of stay or any other appropriate document indicating the purpose of the journey. Information about the party who bears the cost of the trip.</p> <p>Journeys undertaken for medical reasons:</p> <ul style="list-style-type: none"> • Certificate from a medical doctor (designated by the consulate) and/or a medical institution confirming the need of specific medical treatment to be received in the destination country; • An official document of the receiving medical institution confirming that it can perform the specific medical treatment and the patient will be accepted accordingly; • Proof of pre-payment of the treatment; <p>Any other correspondence between the sending medical doctor and the receiving hospitals, if available.</p>			
Flight reservations (roundtrip) , including possible third countries. Please note that it is not			

<p>recommended to purchase the tickets before receiving a visa decision.</p>			
<p>Proof of lodging, hotel reservations, rental of holiday home, campus residence reservation or if stay with a family member or friend, proof of private accommodation (invitation) from the host.</p>			
<p>Proof of sufficient means of subsistence Bank account statements (deposit or savings account) showing the transactions for the last three months. OR If the applicant is financially fully supported by his/her employer, this must be clearly mentioned in the letter of employment.</p> <p>In addition:</p> <ul style="list-style-type: none"> • If the applicant is employed <ul style="list-style-type: none"> ○ The last three payslips ○ Social insurance booklet ○ Employment letter on official company letterhead, stamped and dated; containing contact information (address, email, telephone number) as well as name, position and signature of the countersigning officer. The letter must state the name and position of the applicant, salary, years of employment and approval of absence/position after returning. • If the applicant is a company owner or self-employed <ul style="list-style-type: none"> ○ Certificate of registration of the company ○ The company's last three payslips ○ Statement of taxes payment. • If the applicant is retired: <ul style="list-style-type: none"> ○ Pension statements • Other means <ul style="list-style-type: none"> ○ Regular incomes generated by property ○ Deposit or savings account with certificates regarding the origin of the funds 			
<p>For minors (under 18), a Notary Certificate of family relation (birth certificate) between the minor and the guardians (parents) or other proof of guardianship</p> <p>If travelling alone, a notary certificate of signed permission to travel from both parents or legal guardians</p> <p>If travelling with one parent or legal guardian, a notary certificate of signed permission to travel from the non-travelling party</p>			

If the non-travelling party resides abroad, travel permission must be notarized by the authorities in the country of residence			
Copies of the ID cards of the parents/legal guardians			
Copy of valid residence permit for Vietnam or Laos third country nationals
